

BOB SMITH'S FAMILY FARMING TOMATOES IN THE EARLY DAYS

My name is Ken Baker. I am Bob Smith's Uncle and Mel Smith's brother-inlaw. I always like to tell stories of my past experiences. On my last trip t o


California last year, I was telling Bob about my remembrance as a lad on the farm planting and picking tomatoes. Through research, my friend Nancy Huffman and Bob found pictures of the planter our family used on our farm in lowa. The following is my

plants also. The Baker farm was located N.E. of Morning Sun, lowa and at the age of 13, Kenneth Baker was performing grown men's work. I would rise

> early in h morning during planting season




The planter had metal seats on each side. I would sit on the left

Orwig would sit on the right side. The mechanics of the planter was simple. It would open a furrow, add water (a cup or so) and the boys would set the plant in the water and pack wheels behind the seats would close dirt around the plant.

The Bakers had 5-10 acres each season that they planted and harvested.

I spent at least five seasons helping with the tomatoes before leaving for the service (U.S. Navy) in 1942. I was paid 25 cents per week for planting and worked up to 50 cents per week by the time I left the farm. When the tomatoes were ready to harvest they would be hand picked and also destemmed. Tomatoes would be put into hampers

REPORTS:

President: Dan Kato welcomed everyone to the meeting and informed everyone that member Henry Lynn was not doing well at all. Jack Johnson had just visited him and agreed that he was gravely ill.

Membership: Jim Davis reported that collection of dues at the Madole "Fun Day" on January 9 netted 33% of total members. There are only nine members left to collect. New members voted on: Ross Brock (San Diego), Giles Rowlands (Upland) and Jack Robinson (Santa Ana). All were on motion by Davis and second by Garcia. WAPA welcomes the new members.

Jim Davis announced that Darla Munsinger, Diane Kirkes and Jane Millett are being dropped from membership rolls at their request.

Purchasing: Leroy Overstreet absent.

Library: Jack Johnson reports nothing.

Museum: Craig Maxwell had little to report on museum possibilities. Although he has received a response from the county, there is not any progress on the property being considered.

Glendora Castle: Tom Millett reported that work is being finished up on the International M engine and the tractor crew is now taking on the orchard sprayer and have evaluated the needs to rehab it. Some week days will be added to the schedule if there is enough interest.

Shows: Bob Smith absent. Tom reported that the Bill Leuer yard show in Riverside is tomorrow. Craig Maxwell gave details of the event. The first show for the New Year will be at Highland on March 27. New Business: Larry Madole spoke on his views about establishing a museum. He has deep concerns about how the long term will work out. He would like to have activities be fun and not a laboring task for a few dedicated workers. He used as example, the club equipment such as the tractors and club F/M needing upkeep maintenance and in need of a committee to oversee continual maintenance needs. Bill Baldwin cited as example the way members used to take part in periodic maintenance of everything during the days of Knott's Berry Farm.
