## My View

Back in April of this year when Dean & Barbara Hale donated a pair of line shafts to our WAPA inventory, it sparked my sentimental vibes from my much younger days in the 30's when those shafts were the sole method of transmitting power to several devices at once. I suspect many of our members have not seen these marvelous devices in action. How well I remember my granddad operating his shingle mill with water power and the line shafts that ran underneath the building that sat on the banks of the mill pond. As a ten year old, I loved to go down below to watch those long shafts with a variety of flat belt pulleys as they rumbled with the belts flopping as they turned saws up above. One could actually feel the whole building vibrate. There was the log saw, the shingle saw, the edging saw and the carrier that delivered the cut shingles to the rack, among other machines.

Then there was the town machine shop which sat on the banks of the river. In those days farmers couldn't just go get a replacement part for their machinery. Now I'm not a machinist, so I don't know the types of machines that were in that shop. But, there were many and a long line shaft attached to the rafters had flat belts dropping down to each machine with a long handle device that moved the belt from a drive pulley to an idler. The entire complex of machines was driven by an engine in the range of 10-12 HP with a flat belt running up to the line shaft. The engine exhaust was piped to the outside and cooling water was supplied by a pump that drew it from the river.

It would be great fun for our members to have a place where we could enjoy re-creating that '30-'40 era with machines of our own choosing. Oh well, it's something to ponder before I get much older. By the way, those were NOT "the good old days".

## **WAPA Bylaws revision**

At the April board meeting the board of directors was voting on the termination of members for non payment of dues. After the vote Tom Millett asked the question, "Why do we need to vote them out. If they don't pay then they should automatically be terminated." The bylaws of this organization states that the board must vote them out so that is why at the June board meeting a resolution was passed to change the bylaws so a member is automatically terminated for non payment of dues. In order for this resolution to take effect, we must have one half of the membership vote in favor of this change. Shown below is the text out of the bylaws. The black text is what is currently in the bylaws. The strike through text is what would be removed, and the red text is what would be added. Please read and decide if you are in favor of the change or against. You can vote 2 ways. ### ARTICLE III - MEMBERSHIP

Section Four. Suspension or Expulsion of Membership. ~~The Board of Directors by a majority vote of those present at any regularly constituted meeting, there being a quorum present, may terminate the membership of any member who becomes ineligible for membership, or suspend or expel any member who shall be in default in the payment of dues for a period fixed in Article IV of these Bylaws. In addition, The Board of Directors, by an affirmative vote of a majority of all members of the Board, may suspend or expel a member for conduct that the Board deems detrimental to the objects or interests of the Club or in violation of its constitution, bylaws, code of ethics, or rules and regulations, provided the member is given notice of the proceedings against him and an opportunity to be heard in his own defense.~~

Section Five. Termination of Membership. Membership shall terminate upon death or resignation of a member, or on his expulsion by the Board of Directors. **In addition, a member's membership shall terminate if said member is in default of payment of dues for a period fixed in Article IV of these Bylaws.** On such termination any right, title or interest of the member in or to the property and assets of the Corporation shall cease.

Section Six. Reinstatement. Upon written request signed by a former **expelled** member and filed with the Secretary, **or the paying of dues in the same year a member was terminated for nonpayment,** the Board of Directors, by the affirmative vote of a majority of the members of the Board, may reinstate such former member to membership on such terms as the Board may deem appropriate.

### ARTICLE IV - DUES

Section Three. Default and Termination of Membership. When any member shall be in default in the payment of dues for a period of **three** ~~two~~ months from the beginning of the period in which dues become payable, his membership may thereupon be terminated by the Board of Directors in a manner provided in Article III of these Bylaws.

<b>Vice President</b>	Leroy Overstreet was welcomed back with a round of applause after his absence at events due to his battle with cancer. He had nothing new to report.

<b>Treasurer</b>	Kelley Garcia shared a detailed financial report of the club. As of 5-31-14, the total investments were \$265,849.72. Total assets, which include all WAPA owned property, are \$343,300.10. Kelley reported that she has communicated with a S.B County employee in response to her invoice letter requesting return of funds paid to them when the county voided our contract for land use. All of those employees at the time are no longer there, so the slow wheels of red tape will take awhile.
<b>Membership</b>	Jim Davis submitted a written report as follows: Membership grand total is 164. Paid members are 132, life members (26), Honorary members (5), Charter members (1), Junior members (1). WAPA Member Roster correction: Donald Jensen's e-mail address should read <b>donald-jensen@att.net</b> .
<b>Purchasing</b>	Director Lance Wilson reported that the shirt decal expiration date is coming up. He distributed a color and size chart for t-shirts and asked each member present to check off size & color. He would determine what size and color to stock and use up existing decals.
<b>Shows</b>	Rob Skinner announced that the Steve McQueen Car Show at Boys Republic went well with lots of participation. July 27 <sup>th</sup> is the Marina Del Ray Show. It was sanctioned at the May 3, 2014 board meeting on motion by Rob seconded by Jim Davis. Katie Young, who is in charge of the Tulare Show will appear at a WAPA Board meeting on a yet to be decided date. She will gather input from our members and explain changes contemplated for the future. The Director of the Fort MacArthur military museum would like us to consider making an appearance on an unspecified date to help draw attention to their collection. Rob will work out details.

<b>Glendora Castle</b>	Nothing new.
<b>Cal Poly Restoration Project</b>	Working on repairs to our two wagons in preparation to Cal Poly Pumpkin Festival. Some axels may need replacing.
<b>Riverside Citrus Grove Project</b>	Ron Haskell gave a report on their efforts to plumb the 200 HP Western with air and Propane gas.
<b>Unfinished Business</b>	It was the consensus of the Board and members to make preparations to move the 160 HP Western engine since all known Chino Water Co. shareholders have signed off on donating to WAPA.

Time: Set-up begins at 7:30 am, our vehicles out of area by 8:30 am. The show starts at 10 am and closes at 3 pm.


### Fort McArthur Engine Show & Picnic August 16, Saturday, Starts at 8:00 By Rob Skinner

## Road Trip By Bob Smith

Barbara informed the board that the windmill was in Nevada and would require two strong guys and a trailer. I talked to Barbara and started to plan the trip. She said that it was 250 miles each way and would take about 4.5 hours to get there. I asked Tom Millett if he would like to go and Lance Wilson volunteered to go and furnish the trailer. The plan was for me to drive my pickup and pull Lance's trailer but at the last minute he borrowed Tim Neeley's F350 4-door with a V10. He felt that it would be more comfortable for the third person in the back.

Since it was going to be a long and hot day, I wanted to start early so told Tom that I would pick him up at his house at 3:30 a.m. on Tuesday, June 3 and we would drive to the Walmart North of the 210 just off 215. We met Lance at 4:15 and hit the road.

Lance being a retired Highway Patrol officer, I asked him if we had to stop at the weigh station and he said no. Besides, they don't open until 6:00 a.m. anyway. We commenced up the 215 to 15 and took it through the pass and on to Baker. We pulled into Baker a little after 6:00 a.m. and decided to stop for a pit stop and grab a bite to eat at the quickie mart.

We took off from Baker and proceeded up highway 127 towards Death Valley. It was not a bad 2 lane road and not much traffic. Lance informed us of the times he would travel this stretch of road escorting wide loads out of Nevada. 100 miles later we arrived at Death Valley Junction where we left 127 and proceeded right on State Line Road. Barbara said just over the Nevada state line start looking for a brown wooden sign saying "National Wildlife Refuge. Ash Meadows, Nevada South entrance". She said that if we could not find the sign then go back to Death Valley Junction to the old Opera House and ask where the blind man and his wife live. We never saw the state line sign but we did locate the brown National Wildlife Refuge sign and turned onto a dirt road and took it until we located a quonset hut, trailer, and a yellow butler building.

We found the homestead at around 7:30am and Barbara was there to greet us and open the gate. This piece of land is located in a meadow where the ground water is about 3 feet down and surrounded by the Wildlife Refuge. Dean purchased the land back in 1971 prior to the Wildlife Refuge so he is sitting on quite a nice piece of 40 acres.




